POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 21 NOVEMBER 2016

The board of directors (the “**Directors**” or “**Board**”) of New World Department Store China Limited (the “**Company**”) is pleased to announce that at the annual general meeting of the Company held on 21 November 2016 (the “**AGM**”), all the ordinary resolutions (the “**Ordinary Resolutions**”) as set out in the notice of the AGM dated 21 October 2016 (the “**AGM Notice**”) were approved by shareholders of the Company (the “**Shareholders**”) by way of poll at the AGM. Tricor Investor Services Limited, the branch share registrar and transfer agent of the Company in Hong Kong, was appointed as scrutineer for the poll at the AGM.

As at the date of the AGM, the total number of issued and fully paid up shares of the Company was 1,686,145,000 shares, which was the total number of shares entitling the holders to attend and vote for or against all the Ordinary Resolutions at the AGM. There were no shares entitling the Shareholders to attend and only to vote against the Ordinary Resolutions at the AGM and there were no Shareholders who were required under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited to abstain from voting in respect of any of the Ordinary Resolutions at the AGM.
